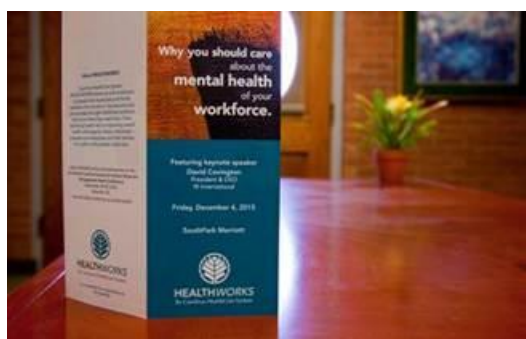
RI International's Courtyard Event featured an exhibit of Dese'Rae Stage's (pictured) [Live Through This](#) participants.
